## Frequently Asked Question:

**Q.** The protocol states that the drug administration must occur 14-42 days before surgery. Many cancer patients will be operated on within two weeks. When would the various visits occur?

**A.** The patient pathway will be different for each hospital. Specifically for cancer patients, there are several routes where they may be identified and screened: through a GP letter at an endoscopy appointment, on referral for a CT or MRI (as normally the patient has had bloods checked for these investigations) or at a MDT. Cancer patients will also often be seen many times before their surgery at various different appointments (clinic, MDT) and these could be utilised and trial visits incorporated.

It may also be useful to go through waiting lists, to identify potential patients earlier.

## Site Initiation Visits

Site visits have now been held at four hospitals; UCLH, Royal Cornwall Hospital, Hillingdon Hospital and Maidstone Hospital. The main reason for the initiation visit is to train the PREVENTT staff in the intervention and randomisation procedures and to go through the site files in detail.

A short presentation on PREVENTT is given at the start and we have found that it is very helpful if the PI is present for this as a number of questions often arise. As the trial also involves pharmacy, it is helpful to meet the pharmacist as well. It is extremely enjoyable and valuable for us to meet the research nurses and team that are involved with PREVENTT face to face.

## Screening Logs

Following site initiation, we will ask when it is likely the site will start screening for eligible patients. At this point you will be asked to begin filling out a screening log, which should include all patients undergoing major abdominal surgery (open or laparoscopic). The log should include details of whether the patients were recruited into PREVENTT. If not recruited the reason why not should be included.

The log will need to be submitted to the coordinating centre at the end of each month. The information provided is then reviewed at the project management meetings, which meet at least twice a month. The screening log provides valuable information with regard to why patients are not being recruited into the trial. This might be used as a basis for a change in exclusion criteria.

If patients are refusing then please provide as much information as to the reasons why.
